College or vocational/technical training that equals at least 30 semester hours, 45 quarter hours, or 720 classroom hours may substitute for the required experience. Licensure or registration is not required. Those hired after September 2015 must have a high school diploma or GED. Level II Screening Compliance (F.S. 435.04 and 409.907).
